- 1. CALL TO ORDER-The meeting was called to order at 7:05 p.m.**

- 3. CONSENT AGENDA**-each item listed on the consent agenda is considered to be routine by the Town Council and will be enacted by one motion. There will be no separate discussion of these items unless a Council Member so requests, in which event the item will be removed from the Consent Agenda and considered in its normal sequence on the agenda. 2. Consider and take action relative to the October 2011 Financial Report

Cindy Aughinbaugh made a motion to approve the items on the consent agenda.  
Charles Grimes seconded the motion. Motion carried 5-0

**4. COUNCILMEMBER/COMMITTEE REPORTS-**Consider and take action relative to the following Councilmember/Committee member reports:

1. Library Board Members (Williams) The Mayor reported that 2 positions have opened on the library board. He asked that anyone interested to please come by Town Hall and fill out an application. The town desperately need 2 board members.
2. New Waste Management Rep (Williams) The Mayor reported that John Kleiber is replacing Gretta as our Waste Management Rep. John Kleiber has previously been our Rep in the past.
3. Road Report (Williams) The Mayor reported that Road items have been placed on the Agenda and will be addressed once the Town Council progresses to that agenda item.
4. Police Report (Grimes) The Mayor reported that the police report for November had not been received prior to this meeting. He is hopeful that this report will be available for the next Town Council Meeting.
5. Strategic Planning Report (Reedy) John Reedy reported that the Strategic Planning Committee has met once and talked about goals included streets, drainage, street lights, lake amenities and beautification. Also discussed was possible gravel or wood chip trails, park and playground, child safety, traffic problems of the new middle school and upgrading technology. They also discussed long term strategic and financial plans for the town. He stated that the committee is still in the early stages and the next meeting will be next week.
6. Community Events Committee-(Spencer) Cindy Spencer reported that the plans are in place for Saturday-Shady Shores Christmas. The event will be held from 10-3, with 21 total vendor spaces and she is very pleased that 19 of those spaces have already been booked. Santa and Miss Claus will be here from 10-1, a storyteller from the library will tell stories from 1:30-3, free goodies and treats for kids and the vendors include food and hot chocolate and crafts. There will be kid's games and prizes and the Boy Scouts will be helping to

monitor the games. There will also be a Gingerbread decorating contest with Mayor Williams and Olive Stephens judging the contest.

7. New Middle School (Williams) The Mayor stated that he met with town attorney and engineer and about 7 dignitaries from the engineering company, architectural company and the school district regarding the new middle school. During the meeting they discussed major issues that are going to be facing this town with the new middle school which were already addressed in 2007. During the meeting he made them very aware that we will tolerate no fast tracked school without all of the concerns and issues being addressed. The Mayor assured that all concerns regarding the middle school will be addressed to the satisfaction of all of the residents before the school will be built.
8. Code Red (Williams)The Mayor stated that the Code Red allows a warning system to come to cell phone, home phone or any other communicative device. If there is a tornado or severe storm approaching our area, it will call you. It's a master computer that will basically instruct you of the situation and what actions you should be aware of. Code Red is allowing the citizens of Shady Shores to participate and the citizens may go to the City of Corinth's website to sign up.

## **5. CITIZENS COMMENTS-PURSUANT TO THE STATE OF TEXAS OPEN**

**MEETINGS STATUTE:** The governing body of the Town of Shady Shores may not take action on items not posted on the agenda. Those items mentioned by citizens may be placed on a future agenda.

Gaye Martin of Hickory Creek spoke about comparison of rates for LCMUA to other surrounding cities. She would like for the council to take into consideration the difference in prices between LCMUA and what others cities are paying and look at options to lower the amount that the citizens are paying.

Tom Spencer of Shady Shores addressed his concerns to the council about the new middle school and the issues of traffic once the school is open. He is concerned with traffic flow on Garza and Shady Shores road.
