

ORDINANCE NO. 236-7-2011

(Amending Ordinance 75 - Traffic Control)

AN ORDINANCE OF THE TOWN OF SHADY SHORES, DENTON COUNTY, TEXAS, AMENDING ORDINANCE NO. 75, BY AMENDING ATTACHMENT A OF ORDINANCE NO. 75 AND SUBSEQUENT AMENDING ORDINANCES TO PROVIDE A COMPREHENSIVE LIST OF INTERSECTIONS WITHIN THE TOWN OF SHADY SHORES WITH TRAFFIC CONTROL DEVICES IN THE FORM OF STOP SIGNS; BY ADDING THE ADDITIONAL STOP SIGN LOCATIONS: COLT LANE AT MUSTANG TRAIL, AND CHAPARRAL DRIVE AT MEADOWLARK LANE; THE FOREGOING ADDED LOCATIONS WITHIN THE TOWN OF SHADY SHORES BEING APPROVED SITES FOR THE PLACEMENT OF A STOP SIGN IN ACCORDANCE WITH STATE RULES AND REGULATIONS; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR A PENALTY OF A FINE NOT TO EXCEED THE SUM OF TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; PROVIDING A PUBLICATION CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on December 5, 1983, the Town of Shady Shores (the "Town") enacted Ordinance No. 75 (which was subsequently amended on February 2, 2005 by Ordinance No. 169-2-2005, on July 7, 2008 by Ordinance 207-7-2008, and on February 7th, 2011 by Ordinance 233-2-2011), adopting provisions for the location of specific traffic control devices within the corporate limits of the Town of Shady Shores and providing for the installation of such devices; and

WHEREAS, the Town Council finds that the addition of the following stop sign locations: Colt Lane at Mustang Trail, and Chaparral Drive at Meadowlark Lane (a) will improve traffic flow, (b) will not compromise the health, safety, and welfare of the citizens, visitors, or motorists utilizing the public roadways within the corporate limits of the Town of Shady Shores, (c) are streets with traffic regulated by the Texas Transportation Code; and (d) will facilitate traffic flow without compromising safety.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SHADY SHORES, DENTON COUNTY, TEXAS:

SECTION 1. Incorporation of Premises. The foregoing premises are found to be true and correct and are incorporated herein as if copied in their entirety.

SECTION 2. Comprehensive List of Stop Sign Locations. Exhibit "A" to this Ordinance shall provide a comprehensive list of stop sign locations within the Town of

Shady Shores. Violations of this ordinance are as described in Ordinance 75, as regulated by state traffic laws.

SECTION 3. Repealer. All provisions of the ordinances of the Town of Shady Shores in conflict with the provisions of this Ordinance be, and the same are hereby, repealed, and all other provisions of the ordinances of the Town of Shady Shores not in conflict with the provisions of this Ordinance shall remain in full force and effect.

SECTION 4. Severability. Should any word, phrase, paragraph, section or portion of this ordinance be held to be illegal, invalid or unenforceable, the legality, validity and enforceability of the remaining portions of the ordinance shall not be affected thereby, and each such illegal, invalid or unenforceable word, phrase, paragraph, section or portion shall not affect the ordinance as a whole.

SECTION 5. Savings. All rights and remedies of the Town of Shady Shores, Texas are expressly saved as to any and all violations of the provisions of any other ordinance affecting traffic control devices which have been secured at the time of the effective date of this Ordinance; and as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances the same shall not be affected by this Ordinance but may be prosecuted until final disposition by the courts. Ordinance No. 75, as amended by this Ordinance, is still in full force and effect.


SECTION 6. Penalty Clause. Any person, firm or corporation violating any of the provisions or terms of this Ordinance shall be deemed guilty of a Class C misdemeanor and, upon conviction, shall be punished by a fine not to exceed the sum of Two-Hundred Dollars (\$200.00) for each offense; and each and every day during or on which such violation shall occur or continue shall be deemed to constitute a separate offense.

SECTION 7. Publication. In accordance with Section 52.011 of the Local Government Code, the caption of this Ordinance shall be published either (a) in every issue of the official newspaper of the Town of Shady Shores for two days, or (b) one issue of the newspaper if the official newspaper is a weekly paper. An affidavit by the printer or the publisher of the official newspaper verifying the publication shall be filed in the office of the Town Secretary.

SECTION 8. Effective Date. This Ordinance shall take effect upon publication of the caption, as the law in such case provides.

EXHIBIT "A"

a. At the intersection of West Shady Shores Road, South Shady Shores Road, Lakeshore Road and Cielo Lane; no traffic approaching this intersection from any direction shall have the right-of-way and there shall be stop signs on West Shady Shores Road, South Shady Shores Road, Lakeshore Road and Cielo Lane directing all traffic approaching this intersection from West Shady Shores Road, South Shady Shores Road, Lakeshore Road and Cielo Lane to stop.

b. At the intersection of West Shady Shores Road and Fritz Lane: traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Fritz Lane directing traffic approaching West Shady Shores Road to stop.

c. At the intersection of Garza Road and Eason Cemetery Road; traffic proceeding in either direction on Garza Road shall have the right-of-way and there shall be a stop sign(s) on Eason Cemetery Road directing traffic approaching Garza Road to stop.

d. At the intersection of Garza Road and 6th Street; traffic proceeding in either direction on Garza Road shall have the right-of-way and there shall be a stop sign(s) on 6th Street directing traffic approaching Garza Road to stop.

e. At the intersection of Garza Road and Smokey Lane; traffic proceeding in either direction on Garza Road shall have the right-of-way and there shall be a stop sign(s) on Smokey Lane directing traffic approaching Garza Road to stop.

f. *(Deleted)*

g. At the intersection of Swisher Road and Chaparral Estates; traffic proceeding in either direction on Swisher Road shall have the right-of-way and there shall be a stop sign(s) on Chaparral Estates directing traffic approaching Swisher Road to stop.

h. At the intersection of Dobbs Road and Berry Lane; traffic proceeding in either direction on Dobbs Road shall have the right-of-way and there shall be a stop sign(s) on Berry Lane directing traffic approaching Dobbs Road to stop.

i. At the intersection of South Shady Shores Road and Dobbs Road; traffic proceeding in either direction on South Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Dobbs Road directing traffic approaching South Shady Shores Road to stop.

j. At the intersection of West Shady Shores Road and Meadowlark Lane; traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Meadowlark Lane directing traffic approaching on West Shady Shores Road to stop.

k. At the intersection of West Shady Shores Road and Shahan Lane; traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Shahan Lane directing traffic approaching West Shady Shores Road to stop.

l. At the intersection of Lakeshore Road and Shahan Drive; traffic proceeding in either direction on Lakeshore Road shall have the right-of-way and there shall be a stop sign(s) on Shahan Drive directing traffic approaching Lakeshore Road to stop.

m. At the intersection of South Shady Shores Road and Oakwood Circle; traffic proceeding in either direction on South Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Oakwood Circle directing traffic approaching South Shady Shores Road to stop.

n. At the intersection of Garza Road and Brown Terrace; traffic proceeding in either direction on Garza Road shall have the right-of-way and there shall be a stop sign(s) on Brown Terrace directing traffic approaching Garza Road to stop.

o. At the intersection of Garza Road and West Shady Shores Road; traffic proceeding in either direction on Garza Road shall have the right-of-way and there shall be a stop sign(s) on West Shady Shores Road directing traffic approaching Garza Road to stop.

p. At the intersection of Oakwood Circle and Berry Lane; traffic proceeding in either direction on Oakwood Circle shall have the right-of-way and there shall be a stop sign(s) on Berry Lane directing traffic approaching Oakwood Circle to stop.

q. *(Deleted)*

r. At the intersection of Fritz Lane and Mustang Trail; traffic proceeding in either direction on Fritz Lane shall have the right-of-way and there shall be a stop sign(s) on Mustang Trail directing traffic approaching Fritz Lane to stop.

s. At the intersection of Brown Terrace and Spring Drive; traffic proceeding in either direction on Brown Terrace shall have the right-of-way and there shall be a stop sign(s) on Spring Drive directing traffic approaching Brown Terrace to stop.

t. At the intersection of Brown Terrace and Cove Drive; traffic proceeding in either direction on Brown Terrace shall have the right-of-way and there shall be a stop sign(s) on Cove Drive directing traffic approaching Brown Terrace to stop.

u. At the intersection of Brown Terrace and Driftwood Drive; traffic proceeding in either direction on Brown Terrace shall have the right-of-way and there shall be a stop sign(s) on Driftwood Drive directing traffic approaching Brown Terrace to stop.

v. At the intersection of Brown Terrace and Shell Drive; traffic proceeding in either direction on Brown Terrace shall have the right-of-way and there shall be a stop sign(s) on Shell Drive directing traffic approaching Brown Terrace to stop.

w. At the intersection of West Shady Shores Road and Carolyn Lane; traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Carolyn Lane directing traffic approaching West Shady Shores to stop.

x. At the intersection of West Shady Shores Road and Hidden Valley Airpark; traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Hidden Valley Airpark directing traffic approaching West Shady Shores Road to stop.

y. At the intersection of West Shady Shores Road and Fox Hollow Run; traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Fox Hollow Run directing traffic approaching West Shady Shores Road to stop.

z. At the intersection of West Shady Shores Road and Lakeside Drive; traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Lakeside Drive traffic approaching West Shady Shores Road to stop.

aa. At the intersection of West Shady Shores Road and Dogwood Trail; traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Dogwood Trail directing traffic approaching West Shady Shores Road to stop.

bb. At the intersection of Shahan Drive and Shahan Lane; there shall be a stop sign on Shahan Drive at Shahan Lane directing traffic approaching Shahan Drive to stop.

cc. At the intersection of Shahan Drive and West Shady Oaks Circle; traffic proceeding in either direction on Shahan Drive shall have the right-of-way and there shall be a stop sign(s) on West Shady Oaks Circle directing traffic approaching Shahan Drive to stop.

dd. At the intersection of Shahan Drive and Red Bud Trail; traffic proceeding in either direction on Shahan Drive shall have the right-of-way and there shall be a stop sign(s) on Red Bud Trail directing traffic approaching Shahan Drive to stop.

ee. At the intersection of Shahan Drive and East Shady Oaks Circle; traffic proceeding in either direction on Shahan Drive shall have the right-of-way and there shall be a stop sign(s) on East Shady Oaks Circle directing traffic approaching Shahan Drive to stop.

ff. At the intersection of West Shady Shores Road and Everett Court; traffic proceeding in either direction on West Shady Shores Road shall have the right-of-way and there shall be a stop sign(s) on Everett Court directing traffic approaching West Shady Shores Road to stop.

gg. At the intersection of Lakeshore Road and Oberman Lane; traffic proceeding in the north direction on Lakeshore Road shall have the right-of-way and there shall be a stop sign on Oberman Lane and on Lakeshore Road traveling west directing traffic approaching Lakeshore Road to stop.

hh. At the intersection of West 6th Street and Shady Lane; traffic proceeding in either direction on West 6th Street shall have the right-of-way and there shall be a stop sign(s) on Shady Lane Street directing traffic approaching West 6th Street to stop.

ii. At the intersection of Lakeshore Road, Smokey Lane, and Francks Circle; no traffic approaching this intersection from any direction shall have the right-of-way and there shall be stop signs on Lakeshore Road, Smokey Lane, and Francks Circle directing all traffic approaching this intersection from Smokey Lane, Francks Circle and Lakeshore Road to stop.

jj. At the intersection of West 6th Street, East 6th Street, and Lakeshore Road; no traffic approaching this intersection from any direction shall have the right-of-way and there shall be stop signs on West 6th Street, East 6th Street, north-bound on Lakeshore Road, south-bound on Lakeshore Road directing all traffic approaching this intersection from West 6th Street, East 6th Street, and Lakeshore Road to stop.

kk. At the intersection of Jay Street and Lakeshore Road; traffic proceeding in either direction on Lakeshore Road shall have the right-of-way and there shall be a stop sign(s) on Jay Street directing traffic approaching Lakeshore Road to stop.

ll. At the intersection of Laura Street and Lakeshore Road; traffic proceeding in either direction on Lakeshore Road shall have the right-of-way and there shall be a stop sign(s) on Laura Street directing traffic approaching Lakeshore Road to stop.

mm. At the intersection of Jay Street and Francks Circle; traffic proceeding in either direction on Francks Circle shall have the right-of-way and there shall be a stop sign(s) on Jay Street directing traffic approaching Francks Circle to stop.

nn. At the intersection of Laura Street and Francks Circle; traffic proceeding in either direction on Francks Circle shall have the right-of-way and there shall be a stop sign(s) on Laura Street directing traffic approaching Francks Circle to stop.

oo. At the intersection of Chaparral Drive and Meadowlark Lane; traffic proceeding in either direction on Meadowlark Lane shall have the right-of-way and there shall be a stop sign(s) on Chaparral Drive directing traffic approaching Meadowlark Lane to stop.

pp. At the intersection of Colt Lane and Mustang Trail; traffic proceeding in either direction on Mustang Trail shall have the right-of-way and there shall be a stop sign(s) on Colt Lane directing traffic approaching Mustang Trail to stop.

qq. The following stop sign on the road indicated at the intersections indicated:

1. On Brown Terrace at Lakeshore Dr
2. On Cedar Circle at Dogwood
3. On Colt at Mustang Trail
4. On Cottonwood Trail at Dogwood
5. On 5th at Lakeshore Dr
6. On Garza at dead-end-through property at North end
7. On Lakeshore at Oberman Dr
8. On Lakeshore at Brown Terrace
9. On Oakwood Circle at Oakwood Circle
10. On Olive's Branch at Garza
11. On Pecan Ct at Dogwood
12. On Shahan Lane coming from extension
13. On Shanan Lane at Shahan Drive
14. On Stapler Dr at W Shady Shores Rd
15. On Cahill at Comanche Drive
16. On Cahill at Paradise Cove
17. On Cheyenne Court at Paradise Cove
18. On Cielo Lane at West Shady Shores Road
19. On Comanche Drive at Rio Bravo Way
20. On Durango Circle at Comanche Court
21. On Mesa Court at Paradise Cove
22. On Peninsula Bend at Paradise Cove
23. On Rio Bravo Way at Paradise Cove
24. On Shadow Lane at Meadow Lark

25. On Sunrise Grove at Golden Meadow
26. On Sunrise Grove at West Shady Shores Road
